## GOLDJUNGE 2024 BREEDING CONTRACT

to the German Riding Pony Goldjunge (DE441411064417). The EARLY BOOKING breeding fee for Goldjunge is \$800.00 for breedings booked before February 1st, 2024 (of which \$100. is considered a booking fee). The Regular 2024 breeding fee (of which \$100. is considered a booking fee) is \$900.00. Collection and shipping fees are additional.

This mare is booked by name and the booking is valid to this mare only. Neither booking nor the return privilege can be transferred without written permission from the stallion owner.

The Mare's health condition is the responsibility of the Purchaser. The Purchaser will insure that the mare is in sound breeding condition. We recommend that purchaser's vet examine and assess your mare's breeding soundness, and your mare should have a negative uterine culture prior to breeding. We expect you to follow your veterinarian's recommendation.

We recommend that the Purchaser vaccinate the mare for Rhinopneumonitis (Equine Herpes Type 1) at 5, 7, and 9 months of pregnancy, the purchaser shall also ensure that the mare is kept in proper condition, and be kept up to date on all worming and all other vaccinations.

The FULL breeding fee must be received before any semen will be shipped.

We strongly recommend that the above named mare be checked for pregnancy and ultrasounded by a veterinarian 14-17 days post breeding. The mare should be re-checked between 28-35 days for pregnancy. The Purchaser must inform Heidi Humphrey of the above named mare's pregnancy status by day 45.

The breeding fee does not include the collection fees, container, or any shipping fees. A Collection fee of approximately \$600.00 per collection will be charged for each collection needed within the same breeding season and must be paid prior each additional shipment of semen. The Purchaser is solely responsible for all shipping fees. Equitainers are available on a first-come first-serve basis and can be used upon request. New disposable containers are available at a cost of \$100. and do not need to be returned. All collection, container and shipping fees will be billed by HH Sportponies and may be subject to change.

HH Sportponies agrees to provide fresh cooled semen viable at the time of collection from Goldjunge to the shipping address provided on the Semen Request Form.

Stallion owner is not responsible for any semen shipments that are lost, delayed or damaged during transport. This semen must be administered by a licensed veterinarian or by a breeding technician approved by HH Sportponies, on the day of delivery, or the Live Foal Guarantee (LFG) and the contractual obligations may not apply.

The Purchaser assumes all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare what so ever by death, disease, injury, infection or otherwise, and by any cause whatever, including inappropriate, untimely, or negligent insemination or failure of insemination and therefore releases, discharges, indemnifies and hold harmless HH Sportponies from any and all damages associated therewith.

The Purchaser agrees that no embryo transfers from the above named mare using semen from a Branley Ash Sportponies stallion are to be done without the prior written permission of HH Sportponies.

If the mare fails to conceive during the 2024 season the Purchaser is entitled to use the breeding in the following two seasons. Purchaser must inform HH Sportponies by no later than October 31, 2024 as to whether the mare is in foal or not. This report must be sent to HH Sportponies, so that the Live Foal Guarantee (LFG) and return breeding will be honored. It will be the Purchaser's responsibility to pay the booking fee, collection fee, shipping, and container fees the following season(s) — costs may vary from year to year.

Live Foal Guarantee: If the mare, after being checked in foal, aborts or does not produce a live foal that can stand and nurse on its own, and survive 30 days after birth, the Purchaser is entitled to a return breeding in the following years (2025 & 26). It will be the Purchaser's responsibility to pay the new season's booking fee, collection fee, shipping, and containers fees. A veterinary certificate is required within five (5) days from the date of death or examination. Otherwise the LFG is Null and void.

A certificate of service will be issued to the mare owner once all fees have been paid in full, and once the stallion owner receives notification of the birth of the foal.

This contract shall be binding upon both parties, when accepted by Purchaser. This contract is transferable only with written permission from the stallion owner.
